LOCATION OVERVIEW

ProLogis Park 81 is conveniently located along the I-81 corridor, within a quarter mile of exit 29, in South Central Pennsylvania. This location is in close proximity to one of the nations largest intermodal yards which is operated by Norfolk Southern. CSX will soon open an intermodal yard within several miles south of ProLogis Park 81. This location allows access to over 50% of the U.S. population within a ten hour truck commute. South Central Pennsylvania is one of the fastest growing Industrial real estate markets due to its convenient access to I-81, I-83, I-78 and the Pennsylvania Turnpike (I-76). This region is also referred to as a key East Coast distribution location and is home to many other significant distribution operations including the following:
